NOTIFICATION

It is being observed that in many occasions inspections are being carried out under West Bengal Shops & Establishments Act, 1963 and Rules framed thereunder just after receiving of application for registration of shops and establishments under the said Act. In many cases these retard the process of disposal of application for registration.

To encourage shopkeepers and employers more to register their shops and establishments under the said Act, the Governor is pleased to eliminate the process of regular inspection prior to registration, under normal circumstances, of those shops and establishments for which applications are received for registration under West Bengal Shops & Establishments Act 1963. This restriction will not be applicable in case of surprise inspection or inspection based on complaints under reference made to him in this behalf or otherwise.

This shall take immediate effect.
