Notice

Notice is given to all the existing beneficiaries of FAWLOI Scheme of erstwhile Kolkata South, Kolkata North and Kolkata Central regions (now falling under unified Kolkata region) that **financial assistance for the year 2019-2020** shall be provided to the eligible persons on the basis of Self-Declaration to be made on a plain paper in the **prescribed format(Copy enclosed)**. Such Self- Declaration, duly filled in, shall be received from them in the office of the Labour Commissioner, New Secretariat Buildings, 11th Floor 1, K.S. Roy Road, Kolkata-1 on all working days from **11.00 a.m. to 1.30 p.m. and from 2.30 p.m. to 4.30 p.m as per schedule below.**

The beneficiary shall be required to bring with him all the original testimonials relating to Employment, Date of Birth and the details of Bank Account etc. for production at the time of submission of the Self-Declaration. The Self-Declaration must have with it the photocopies of the following documents as its enclosures:-

- a. The first page (not the cover page) and the last page with updated entries of the Bank Pass Book for the designated Account,
- b. The Receipt/ Acknowledgement with Application Number issued to him from this office at the time of making the initial application for financial assistance and
- c. ESI Card
- d. The copy of Self-Declaration for the last year (2018-19) duly stamped and signed by the Official as receipt.
- e. Any other documents, if available.

The **IFS Code** of the Branch of the Bank **and** the **MOBILE PHONE NUMBER** of the beneficiary **MUST** be given in the Bank details and the address for communication respectively. **THE WORKMAN HAS TO PRESENT HIMSELF DURING SUBMISSION OF SELFDECLARATION.** All the fields in the Self-Declaration must be filled up. The entries in the Self- Declaration must be legible. Incomplete/illegible/mutilated copy of the Self-Declaration or such Self-Declaration without **IFS code/ mobile number shall be rejected.**

In case the beneficiary, resigns from service, receives terminal dues from the employer, accepts final dividend from the Official Liquidator, High Court arising out of Liquidation of the company, receives pension from EPFO or dies after submission of the declaration it shall be the duty of the incumbent or his/her nominee(if any) or the office bearer of the countersigning Trade Union, as the case may be, to report the incident to this authority/office immediately and under no circumstances the nominee shall close the bank account of the beneficiary without permission of the authority.

In case the beneficiary is unable to produce any of the documents referred to above, the receiving officials shall receive the Self-Declaration on production of the proof of making an application by the beneficiary to the appropriate authority for having a duplicate copy of the unavailable document.

The Self-Declarations received during the above mentioned period shall qualify for consideration of payment of benefit for the full year. Self-Declarations received after the period shall not be considered for payment of arrears of the benefit.
