Smt. Dola Sen,M.P. stressed upon the need to take care of coverage of the Budli / Special Budli workers covered under Labour Department Notification no.187-IR Dated 01.03.2013 in respect of the above Jute Mills at the time of processing of applications. Other representatives of different Trade Unions supported her proposal. Smt. Sen pointed out that the Contractual workers who are on the roll of M/s Vivekananda Forgings Ltd. are not getting the benefit although the Unit is under coverage. After a lot of deliberations, the Committee decided to seek a report from RLO, Uluberia regarding the status of Contractual Workers on the muster roll of the Company and who worked for 240 days in a year prior to SOW.

Smt. Sen, M.P. gave a suggestion to examine the following Units for coverage under the Scheme—
(a) Ramswarup under RLO, Kharagpur (b) Bhaskar Srachi under RLO, Durgapur (c) Spong Iron Factories namely (i) Gobinda Impex (ii) Manaksia (iii) Maxil and (iv) Eureka at Borjora area under RLO, Bankura . The Committee decided to refer the cases to respective RLOs for enquiry and recommendation in appropriate cases.

The Committee decided to make an assessment of the effectiveness of the Scheme and accordingly requested the Labour Commissioner to arrange for a study of the working of the Scheme and submit his report as early as possible.

As there was no other issue left for discussion, the meeting ended with vote of thanks to and from the chair.
