Sri S. Suresh Kumar,, IAS, Additional Secretary, Labour Department, Govt. of West Bengal and Chairman, Screening Committee took his Chair and welcomed the members present. The proceeding of the 50th meeting of the Committee held on 31.08.2018 was approved. There after agenda-wise discussion took place.

During the course of discussion it was felt that some relaxations of the FAWLOI Scheme are necessary to address the acute financial crisis and hardship of the workers of jute mills of the State, wherein Suspension of Work/ Closure/lockout declared by their management. A similar relief was given earlier to the workers of abandoned tea gardens of the State vide Labour Department Order No. 897-IR/ IR/12L/16/08 dated-8th July, 2014.

After threadbare discussion, considering the gravity of the matter and in order to avoid any sort of discrimination amongst the industrial workmen the following guidelines have been considered for providing financial assistance to the distressed workers of the jute mills/ other industrial units of the State, under SOW/Closure/ lock out, in relaxation of the existing norms of FAWLOI contained in Resolution No. 506-IR dated-14.05.98:

- The workers of the jute mills, wherein SOW/Closure/ lock out declared by their management, may be covered under FAWLOI Scheme provided such jute mills are not in operation for at least six month due to such SOW/Closure/ lock out.
- 2. The workers of the industrial units other than jute mills, wherein SOW/Closure/ lock out declared by their management, may be covered under FAWLOI Scheme provided such industrial units are not in operation for at least six month due to such SOW/Closure/ lock out.

In line with the above guidelines the following four units would qualify to be covered under the Scheme with effect from the date as mentioned against their names in the following table:-

Benefit of FAWLOI was discontinued to the workers of M/s. Hooghly Mills Project Ltd., Mongalpur Unit, Ranigunj, Dist- Paschim Bardhaman w.e.f. 01.04.2018 since a question from reliable source was raised regarding the eligibility of the said workers for the coverage under the scheme. A thorough investigation into the matter was conducted by the officials of Assansol RLO and it was found on enquiry that all the beneficiaries have valid P.F. and ESI No. Accordingly RLO Asansol recommended for continuation of financial assistance to the said workmen. The recommendation of the Asansol RLO was considered by the Committee and approval given.

Regarding contractual workmen of M/s. Vivekananda forgings Ltd., who are on the roll and worked for 240 days in a year prior to SOW, the Committee decided to seek report from RLO, Ulberia regarding the status of contractual workers on the muster roll of the Company.

As there was no other issue left for discussion, the meeting ended with vote of thanks to and from the Chair.
