The BM-SSY Notification No. Labr/1447/(LC-LW)/LABR-25027(11)/1/2020 was published on 05.10.2020 & the process of making new Rules & Regulations of BM-SSY is under process. The existing Rules of the WBB&OCWWS need to be amended in future from time to time to maintain conformity with the spirit of new Scheme BM-SSY and Rules made there under. The Board Members discussed and approved the Scheme.

# Agenda No. 6: Effecting new procedure to facilitate faster implementation and rolling out of the Scheme.

Official works under the Government of West Bengal has entered into electronic mode a few years back to avoid complexity involved in conventional mode. Keeping in view of that situation, changes are being introduced into the works of Board in phased manner to reduce physical contact points as far as practicable. Proposals are placed before the Board members, to approve introduction of beneficiary friendly work structure on 'as and when required' basis to facilitate faster implementation of the Scheme.

Hon'ble Board Members unanimously approved the new procedure to facilitate faster implementation and rolling out of the Scheme.
