Proceedings of the 43rd Meeting of the WBB&OCWW Board held on 17.01.2024 at 02:00 p.m. in the Conference Hall, Labour Department, N. S. Buildings (12th Floor), Block - A, 1, K. S. Roy Road, Kolkata - 700 001

The Hon'ble Minister-in-Charge, Labour Department took the chair and welcomed all present in the meeting. The meeting was presided over by Sri Ritabrata Banerjee, Chairperson, West Bengal Building & Other Construction Workers' Welfare Board (Board). He too welcomed all present and requested the Secretary of the Board to initiate agenda wise discussion. The list of the members, invitees and officials who attended the meeting is annexed herewith.

- 1) The Proceedings of the 42nd Board Meeting held on 16.08.2023 was confirmed and the Action Taken Report in this regard was discussed at length.
- (a) Sri Debanjan Chakrabarti, representative of C.I.T.U raised the issue regarding the House for All scheme and requested to give the details of the modalities of this scheme. The Hon'ble MIC suggested to constitute a committee with Trade Union representatives for deliberating in detail of this scheme and propose a *modus operandi* for implementation of this scheme for the construction workers in West Bengal. This proposal was welcomed by all and the committee was constituted with the following members:
 - i. Sri Ritabrata Banerjee;
 - ii. Sri Sakti Pada Mandal;
 - iii. Sri Bikash Ghatak;
 - iv. Sri Dilip Bhattacharya; and,
 - v. Sri Ashok Ghosh.
- (b) Sri Debanjan Chakrabarti, representative of C.I.T.U raised issues related to interest credited on the Solatium Fund maintained at the PAO-II, Kolkata and the Cess collected from the Big Housing Projects as per his submission in one of the earlier meeting of the Board. It was informed that Finance Department had already issued specific order in this regard and the HMIC asked the Secretary to place the specific order relating to the matter in the next Board meeting. However, it was noted that the issue is currently under further process with the Finance Department, West Bengal.
- (c) The Chairperson of the Board informed that reply to the issue of cess collection was received from the Pujali Municipality and Budge Budge Municipality. The compiled status report as available will be placed in the next meeting.
- (d) Regarding the issue of income tax, the Labour Commissioner, West Bengal and Member-Secretary of the Board suggested that since both the BoCW Act and the Cess Act were Central Acts, the Ministry of Labour & Employment, Government of India may be requested to take up the income tax issues with the Ministry of Finance in a befitting manner.

- 2) The Annual Accounts of the Board for the year 2022-23 for the year 2022-23 was prepared by the Auditor Firm engaged for the purpose and placed before the Board Members for discussion and approval. The same was approved. However, the Hon'ble MIC stated that any issue regarding the said accounts may be discussed in the next Board meeting, if required.
- 3) The proposal for construction of additional (new) Health Centres and Creches was discussed after this. It was made clear that while considering the matter, preference would be given to new areas / locations. Any request / proposal for additional such facilities in the already approved areas / locations will be considered at subsequent stages, if found necessary.

However, new Health Centres were proposed to be built on the land provided by the following Tea gardens / Cinchona plantation:-

- (a) Majherdabri Tea Garden (Dist. Alipurduar);
- (b) Mungpoo Area. (Dist. Darjeeling);
- (c) Ambotia Tea Garden (Dist .- Darjeeling);
- (d) Putinbari Tea Garden (Dist. Darjeeling);
- (e) Matidhar Tea Garden (Dist. Darjeeling);
- (f) Bhojnarayan Tea Garden (Dist. Darjeeling); and,
- (g) Ashapur Tea Garden (Dist. Darjeeling).

In addition, new Creches were proposed to on the land provided by the following Tea gardens / Cinchona plantation:-

- (a) Mungpoo Area (Dist. Darjeeling);
- (b) Labdha Division (Dist. Darjeeling);
- (c) Rambi Division (Dist. Darjeeling);
- (d) Ranju Valley Division (Dist. Darjeeling);
- (e) Rashep Division (Dist. Darjeeling);
- (f) Munsong Division (Dist. Darjeeling):
- (g) Burmaik Division (Dist. Darjeeling);
- (h) Sangsay Division (Dist. Darjeeling);
- (i) Kashyem Division (Dist. Darjeeling);
- (j) Rangpu Division (Dist. Darjeeling);
- (k) Latpanchor Division (Dist. Darjeeling);
- (l) Sittong Division (Dist. Darjeeling);
- (m) Rongo Division (Dist. Darjeeling);
- (n) Dalgaon Division (Dist. Darjeeling);
- (o) Gairibas Division (Dist. Darjeeling);
- (p) Namring Tea Garden. (Dist.- Darjeeling);
- (q) Nischintapur Tea Garden (Dist.- Darjeeling);

- (r) Putinbari Tea Garden (Dist.- Darjeeling);
- (s) Fulbari Patan Tea Garden (Dist.- Darjeeling);
- (t) Ord Terai Tea Garden (Dist. Darjeeling);
- (u) Azambad Tea Garden (Dist. Darjeeling);
- (v) Girish Chandra Tea Garden (Dist. Darjeeling);
- (w) Manjha Tea Garden (Dist. Darjeeling);
- (x) Ashapur Tea Garden (Dist. Darjeeling);
- (y) Saidabad Tea Garden (Dist. Darjeeling); and,
- (z) Jayantika Tea Garden (Dist. Darjeeling).

The proposal for inclusion of all the Creches and Health Centres as stated above were approved. Sri Debanjan Chakrabarti, representative of C.I.T.U, however, dissented to this proposal. The Secretary of the Board then read out the recent advisory issued by the Ministry of Labour & Employment, Government of India dated 06.09.2022 and 01.12.2023 in connection with the activities / schemes to be undertaken by the BoCW Boards.

Apart from this, it was noted that the already approved Creche at Trishakti Tea Garden (Dist. - Darjeeling) and Health Centre at Engo Tea Garden (Dist. -Jalpaiguri) had to be dropped as suitable land in this place was not available at present. The detailed list of the updated locations of the Creches and Health Centres will be annexed with the meeting resolution.

It was resolved that the construction work of the Creches and Health Centres under the Hill Region of the Darjeeling district is to be implemented through the Gorkhaland Territorial Administration (GTA), Darjeeling. The building plans would be drafted by them along with detailed project report indicating cost of construction of each. The budgetary allocation required for the newly included Creches and Health Centres will be transferred to the GTA for smooth implementation of the scheme in that region.

Sri Dilip Bhattacharya, representative of A.I.U.T.U.C held that such creches and health centres need to be constructed in all the Districts across West Bengal. It was stated by the Hon'ble MIC that the construction work of these creches and health centres were so far taken up as pilot project. Similar initiative will be taken in other districts in phased manner. Sri Ritabrata Banerjee, the Chairperson of the Board informed that similar initiative will be taken shortly in the Murshidabad District, where concentration of the construction workers is relatively high.

4) The items required for the Creches like cradles (cot / pillow / mat / baby blanket / diaper), toys (play materials), cooking utensils, gas connection (LPG), water purifier, mosquito net etc. were discussed. It was decided that the Board will prepare a draft of the modalities for procurement of these items along with the requirement of the items as stated above for running of the creches. The North Bengal Development Department will take further necessary action for procurement of the items and funds will be placed to the NBDD accordingly.

- 5) The proposal of purchase of 11 buses for the transportation of the school going children of the construction workers in the Jalpaiguri and Alipurduar districts was placed before the Board Members. The detailed modalities of such procurement will be placed in the next Board Meeting.
- 6) The matter of construction of accommodation/guest house at Digha, Puri, Bolpur, Rampurhat, Darjeeling and Chennai were discussed as follows:-
- a) An amount of Rs. 1,64,900/- (Rs. One Lac Sixty-Four Thousand Nine Hundred) only was released in favour of Haldia Development Authority for sub soil investigation of the plot of land already made available to the Board for construction of Guest House at Digha, District -Purba Medinipur. The said test has been accomplished and the draft building plan has been received. After approval of the Building Plan, at least 25% of the approved budget will be released in favour of the HDA for construction of the Guest House as suggested by the HMIC and Chairman of the Board.
- b) A letter was issued to the District Magistrate Birbhum vide Memo No 006/016/2022-23/WBCWB dated 05/01/2024 for identifying suitable land for the purpose of construction of the Guest House at Rampurhat, Dist. -Birbhum.
- c) A joint visit was made at the Happy Valley Tea Garden, Darjeeling by the Board Officials and NOC will be received from the Tea Garden Authority concerned for construction of the Guest House at Darjeeling.
- d) The fact regarding Puri was that a few existing guest houses were already identified / short-listed and visited by the Board Officials. The Hon'ble MIC suggested that the Board Members may visit these identified buildings in Puri at an early date and suggest which building to be selected as Guest House (on lease basis as purchase).
- 7) After this, the current status regarding construction of Hostel / Transit Accommodation-cum-Training Centre, was discussed.
- a) Plots of land have been identified at Malbazar (Dist.- Jalpaiguri), Siliguri (Dist.- Darjeeling), Haldia (Dist.- Purba Medinipur) and Purulia (Dist.- Purulia). It was noted that the plot of land already obtained for construction of the Shramik Bhavan at Purulia will be handed over to this Board for the construction of the Hostel / Transit Accommodation-cum-Training Centre. A letter in this regard has already been issued to the District Magistrate, Purulia vide No 1115/Est./LC dated 29.11.2023. The matter needs to be followed up as required.
- b) The committee observed that the plot of land identified by the District Administration, Darjeeling at Shishabari, P.S. Matigara, Siliguri need to be changed since it was remotely located. The Hostel / Transit Accommodation-cum-Training Centre of Siliguri will be constructed on the land of the West Bengal Labour Welfare Board at Dagapur, Siliguri, adjacent

to the Shramik Bhavan. The West Bengal Labour Welfare Board would be requested to issue NOC for this purpose.

- 8) The present status of funds already released in favour of NBDD and ADDA for the construction of Health Centres and Crèches was discussed as follows:-
- a) The utilisation certificate for the fund allotted previously was received from NBDD vide Memo No. 3440/NBDD/BS dated 22.11.2023. Thereafter, an amount of Rs. 35,93,88,435/- (Rs. Thirty-Five Crore Ninety-Three Lac Eighty-Eight Thousand Four Hundred Thirty-Five) only was released against the tendered amount for 35 Health Centres and 60 Creches. The matter was accorded *post facto* approval. It was noted that a total amount of Rs. 95,03,32,435/- (Rupees Ninety-Five Crore Three Lac Thirty-Two Thousand Four Hundred Thirty-Five) only was released so far from the end of the WBB&OCWW Board to the NBDD.
- b) The Asansol Durgapur Development Authority has communicated that an amount of Rs. 5,74,56,637/- (Rupees Five Crore Seventy-Four Lac Fifty-Six Thousand Six Hundred Thirty-Seven) only would be the land premium for long term lease based on land market value as determined by the ADSR, Asansol. The land premium fees was approved by the Board and it will be released as soon as ADDA sends the bank account details in which the fund is to be transferred.
- 9) The expenditure incurred by the Board for the period from 01.08.2023 to 31.12.2023 was discussed and *post facto* approval was accorded.
- 10) The issue of refund of wrongly deposited cess to the applicant depositor against claims was discussed and the refund was approved for the following six cases:
 - a) Vivekananda Gram Panchayat, Vill. Kamalpur, P.O. Balighai, Dist. Purba Medinipur;
 - b) Office of the Municipal Councilors of Basirhat, Dist. North 24 Parganas, PIN-743 411;
 - c) Office of the Executive Engineer, Siliguri Irrigation Division, Siliguri, Dist. Darjeeling;
 - d) Executive Officer, Deganga Panchayat Samity, Dist. North 24 Parganas:
 - e) Purbasthali Gram Panchayat, Dist. Purba Bardhaman; and,
 - f) Sahebnagar Gram Panchayat, Dist. Nadia.

The refund to the applicant depositor against claims already submitted was approved in each of the above-mentioned six cases.

- 11) The miscellaneous issues as stated below were also discussed :-
- i) The Additional Chief Secretary, Labour Department proposed that the good practices of other states regarding various welfare measures adopted by them needs to be followed. He further stated that a team of Board Members and Board Officials may visit those states for witnessing the Welfare Activities and subsequently propose for their implementation in this state.
- ii) Sri Dilip Bhattacharya, representative of A.I.U.T.U.C recalled that construction workers used to receive education benefit as well as wage compensation due to illness in the pre BM-SSY era

at the time of hospitalisation. However, these benefits were not incorporated in the BMSSY Scheme for the construction workers. The Chairperson of the Board suggested that this issue may be included in the agenda of the next Board meeting.

iii) Sri Debanjan Chakrabarti, representative of C.I.T.U raised issues related to accidental death at the workplace in recent time increased. The Director of Factories however informed that in case of fatal accident, inspection from the end of the Factories Directorate is carried on and reported to the authorities concerned. Both the Chairman of this Board and the ACS, Labour Department suggested that this should be included in the agenda of the subsequent Board meeting and special inspections are to be undertaken in some of the highrise building construction sites.

iv) The proposal for assessment of the hardware infrastructure of the LWFCs was approved in the 42nd Board meeting held on 16.08.2023. Thereafter, the assessment has been made by the DLCs in every district. As per the report, 394 Desk Top Computer Sets and 413 Printers with Scanners are required to give IT related support to the LWFCs. Further, one colour printer, two Mono Laser Printer and one external hard disk was also required by the Board Office. The matter was discussed and approved. The items will be procured through the GEM portal.

v) A writ petition (WPA 17034) was filed in the Hon'ble High Court at Calcutta regarding inaction on the part of Chairman, CBDT considering and taking a final decision about the application of the Board for exemption under section 10(46) of the Income Tax Act, 1961. The case was disposed by the Hon'ble High Court and the CBDT was directed to consider the application of the Board. Subsequently, the CBDT rejected the prayer. The Board is preparing for filing another writ petition before the Hon'ble High Court at Calcutta. The matter was discussed and approved by the Members.

There being no other point to discuss, the meeting was ended with vote of thanks to and from the Chair.
