Proceedings of the 44th Meeting of the WBB&OCWW Board held on 13.02.2024 at 03:30 p.m. in the Conference Hall, Labour Department, N. S. Buildings (12th Floor), Block - A, 1, K. S. Roy Road, Kolkata-700 001

The Hon'ble Minister-in-charge, Labour Department took the chair and welcomed all present in the meeting. The meeting was presided over by Sri Ritabrata Banerjee, Chairperson, West Bengal Building & Other Construction Workers' Welfare Board (Board). He too welcomed all present and requested the Secretary of the Board to initiate agenda wise discussion. The list of the members, invitees and officials who attended the meeting is annexed herewith. It was noted at the very beginning that Sri Debanjan Chakrabarti, member of the committee & representative of C.I.T.U; Sri Biplab Bhatta, member of the committee & representative of A.I.T.U.C; and, Sri Ashok Ghosh, Invitee of the committee & General Secretary, U.T.U.C Central Committee have informed in writing about their inability to be present in the meeting due to other engagement. However, discussions took place as follows:-

- 1. The Proceedings of the 43rd Board Meeting held on 17.01.2024 & its Action Taken Report were discussed and confirmed.
- The release of fund to different project implementing agencies for construction of the Crèches, Health Centres, Guest House and Hostel / Transit Accommodation-cum-Training Centres etc. was discussed and approved as follows:-
- a) The construction of 13 Crèches in the North Bengal region is already completed and 10 Crèches are expected to be completed at an early date. The modalities of running the Crèches was intimate to the North Bengal Development Department (NBDD) vide Memo No. 087/009/2022-23/WBCWB dated 02.02.2024. Now, an amount of Rs. 3,42,05,600/- (Rs. Three Crore Forty-Two Lac Five Thousand and Six Hundred) only is approved to be released in favour of NBDD as one time cost for purchase of logistics, remuneration for the SHG group for 1 year and cost towards recurring expenses for 1 year for 23 (13 already complete plus another 10 on the verge of completion) Crèches.
- b) The Gorkhaland Territorial Administration (GTA) has submitted the estimated budget for construction of 15 Crèches and 2 Health Centres under the GTA area in Darjeeling and Kalimpong districts amounting Rs. 30,12,04,847/- (Rupees Thirty Crore Twelve Lac Four Thousand Eight Hundred Forty-Seven) only and Rs. 4,00,71,633/- (Rupees Four Crore Seventy-One Thousand Six Hundred and Thity-Three) only. After discussion, 25% of the estimated amount was approved to be released amounting Rs. 8,53,19,120/-(Rs. Eight Crore Fifty-Three Lac Nineteen Thousand One Hundred and Twenty) only in favour of the GTA (25% of the estimated amount, i. e. Rs. 30,12,04,847/- + Rs. 4,00,71,633/- = Rs. 34,12,76,480/-) for smooth implementation of both the schemes in that region. The administrative approval for the purpose would be issued in this respect and the GTA would simultaneously inform the relevant Head of Account or Bank Account details for facilitating the process of fund transfer as already stated.
- 3. The Proposal of one additional Health Centres at Namring Tea Estate, District Darjeeling was placed before the Board Members. It was accorded approval and the Gorkhaland Territorial Administration (GTA), Darjeeling will be the implementing agency of this Health Centre as decided in respect of the GTA area on the earlier occasion.

The comprehensive lists of Crèches and Health Centres approved so far are appended hereto.

4. The proposal of hiring of 11 buses of 40 seats from the North Bengal State Transport Corporation (NBSTC) along with the requisite drivers and conductor / helpers for school-going children of the construction workers of Jalpaiguri, and Alipurduar was discussed. It was accorded approval of the Board and the NBSTC will be requested to allot such buses in favour of the District Magistrates of Jalpaiguri and Alipurduar Districts. The Board would issue letters to both the NBSTC and NBDD informing the matter and the NBDD would issue NIQ / Tender as required for the purpose. It was

- further resolved that when the operation of these buses become full-fledged, the WBB&OCWW Board will release necessary fund (fuel and other expenses) to the District Magistrates concerned on requisition submitted to the Board at periodical intervals.
- 5. The proposal for financial assistance to the beneficiaries who are hospitalised for 5 days or more due to any ailment under Rule 274 was discussed and accorded approval on principal. Such beneficiary will get an amount of Rs. 500/- for first five days, and thereafter Rs. 200/- for each day for the remaining period of hospitalisation, subject to a maximum of Rs. 20,000/- per year. The Additional Chief Secretary, Labour Department requested the Secretary, WBB&OCWW Board to prepare a detailed SOP for this benefit under BMSSY scheme for the construction workers in due course. However, this assistance would be given effect to on and from 1st April, 2024.
- 6. The next agenda for discussion was regarding construction of accommodation/guest house at certain locations. The following decisions were taken:
 - a) <u>Darjeeling</u>: NOC is expected to be received from the Happy Valley Tea Garden Authority for construction of the Guest House at Darjeeling.
 - b) Puri: The Board Members to visit shortly and submit their view thereafter.
- 7. The current status regarding Hostel / Transit Accommodation-cum-Training Centre was discussed as follows:
 - a) The Hostel / Transit Accommodation-cum-Training Centre of Siliguri will be constructed in the land of the Labour Welfare Board at Dagapur, Siliguri, adjacent to the Shramik Bhavan (beside the pump house in the said premises). A letter had been issued to the Welfare Commissioner, West Bengal Labour Welfare Board for issuing NOC of the land measuring 1 acre vide 089/024/2022-23/WBCWB dated 02.02.2024. The Chief Executive of GTA has submitted Building Plan along with detailed project report for this purpose vide Memo No. 85 / I-I / Correspondence /CE / GTA / 2023-24 Dated 11.02.2024 amounting Rs. 14,24,31,633/ (Rupees Fourteen Crore Twenty-Four Lac Thirty-One Thousand Six Hundred and Thirty-Three) only. The Pan was duly approved and it was resolved to release 25% of the estimated budget after receiving the NOC in this regard. It was further resolved that the West Bengal Labour Welfare Board would issue NOC in line with the one already given in case of Digha Guest House (ABASARIKA).
 - b) The Secretary, WBB&OCWW Board proposed to use the vacant place in the newly constructed Shramik Bhavan at Berhampore, Murshidabad for the purpose of Hostel/Transit Accommodation-cum-Training Centre of the Murshidabad District. The Chairman of the Board proposed for utilising one floor for this purpose. It was decided that the Board will take possession of one floor (to be decided subsequently) of the Shramik Bhavan on rental basis. The Board will move a proposal to the Labour Department for the purpose. Two 10 bedded dormitories with toilet blocks in each shall be required for the purpose. The Board will release necessary fund for the procurement of the items required in this regard. The Additional Chief Secretary, Labour Department also proposed to use the said area for Training / Skill Development of the construction workers.
- 8. The expenditure incurred by the Board during the period from 01.01.2024 to 31.01.2024 was discussed and *post facto* approval.
- 9. The following miscellaneous issues were discussed :-
 - (a) The Additional Chief Secretary, Labour Department proposed that Model Health Centre may be constructed in all the sub-divisions across West Bengal to provide medical support for the construction workers and their dependents. The ESI Directorate will provide the Medical Officer and other personnel (support staff) as per their presence in the respective subdivisions / locality. In other cases, the Board would hire the services of the Medical Officer and other personnel Certain basic medicines would be provided free of cost medicines and the expenses will be borne by the WBB&OCWW Board. It was decided that the detailed proposal



- will be discussed in due course after ascertaining the exact locations and corresponding numbers of such Health Centres that may be built.
- (b) The Additional Chief Secretary, Labour Department also suggested that a mobile application may be developed to facilitate registration of building and construction workers.
- (c) The issues related to accidental death at the workplace in recent time was discussed. It was reiterated that assistance can be provided only if the worker is registered. The Additional Chief Secretary, Labour Department proposed to discuss this agenda in due course. However, the information regarding registration of establishment under the BoCW Act will be shared with the Chief Inspector of Factories / Factories Inspector concerned to facilitate their assigned role in regard to safety and security as mandated under the Act.
- (d) The issue of death benefit claim of Rs. 2,00,000/- (Rs. Two Lakh) only in favour of Rasida Bibi, mother of the deceased beneficiary Jabed Mallick of Kharar Municipality was discussed and duly approved as a special case.
- (e) Renewal of Engagement of 2 (two) Contractual Staff of the Board was approved:
