Notice is given to all the existing beneficiaries of FAWLOI Scheme of erstwhile Kolkata South, Kolkata North and Kolkata Central regions (now falling under unified Kolkata region) that financial assistance for the period from April 2023 to September 2023 in financial year 2023-2024 shall be provided to the eligible persons on the basis of Self-Declaration to be made on a plain paper in the prescribed format (Copy enclosed). Such Self-Declaration, duly filled in, shall be received at the above addressas per the schedule below.

There occurred a great number of changes/adjustments in the banking sector regulations or functioning of the banks wef 1st April, 2021 or thereafter due to which the branch IFS code of the account of the beneficiary might change. Therefore, the beneficiary is advised to be careful about providing the correct information while making the Self-Declaration...

All the fields in the format of the Self-Declaration must be duly filled in. The entries in the Self-Declaration must be legible. Incomplete/illegible/mutilated copy of the Self-Declaration or such Self-Declaration without correct IFS code/ mobile number shall be rejected.

In case the beneficiary, resigns from service, receives terminal dues from the employer, accepts final dividend from the Official Liquidator, High Court arising out of Liquidation of the company, receives pension from EPFO or dies after submission of the declaration it shall be the duty of the incumbent or his/her nominee(if any) or the office bearer of the countersigning Trade Union, as the case may be, to report the incident to this authority/office immediately and under no circumstances the nominee shall close the bank account of the beneficiary without permission of the authority.

The Self-Declarations received during the above mentioned period shall qualify for consideration of payment of benefit only for the period mentioned above. not for the full year.
