Sub:- Rates of daily wages of daily-rated workers under the Government whose wages are not regulated by any of the statutory provisions like the Minimum Wages Act, etc.

Sir,


This is to inform you that the rates of daily wages for the workers as mentioned above were enhanced under the Govt. of West Bengal, Finance Deptt. Audit Branch Memo. No. 3300(65) dt. 04.05.09 and thereafter under Memo. Nos.10900-F(P) dt. 09.12.2009, 2580-F(P) dt. 06.04.2010, 10850-F(P) dt. 23.11.2010, 11080-F(P) dt. 12.12.2011, 10615-F(P) dt. 31.12.2012, 8840-F(P2) dt. 16.12.2013, 143-F(P) dt. 09.01.2015, 8430-F(P2) dt. 14.12.2015. Now, under Memo. No. 18-F(P2) dt. 02.01.2017 the existing rates of wages have further been increased by Rs.21/- (Rupees twenty one) only w.e.f. 01.01.2017.

Hence the daily rates of wages would now be as follows:

Categories	Rate(Rs.)
Group-'D'	302.00 (281.00+21.00)
Driver	312.00 (291.00+21.00)
Group-'C'/L.D.C./Typist	313.00 (292.00+21.00)


