*NOTIFICATION*

In exercise of the power conferred by Section 6 of the Contract Labour (Regulation and Abolition) Act, 1970 (37 of 1970) and in supersession of this department notification No. 131-LW/LW/3A-27/79, dated the 7th February, 1980, the Governor is pleased hereby to appoint the persons mentioned in the entries in the column (1) of the table below, being Gazetted Officers of Government to be the Registering Officers for the purpose of Chapter III of the Act, and to define the limits shown in the corresponding entries in column (2) thereof within which such registering officers shall exercise the powers conferred on them by and under the said Act.
