NOTIFICATION

No.238-LW /1A-01/2009.— dated 23.03.2011.— In exercise of the power conferred by section 35 of the Contract Labour (Regulation and Abolition) Act, 1970(37 of 1970) (hereinafter referred to as the said Act), the Governor is pleased hereby to make after previous publication, as required by sub-section (1) of section 35 of the said Act, the following amendments in the West Bengal Contract Labour (Regulation and Abolition) Rules, 1972, as subsequently amended (hereinafter referred to as the said rules):—

Amendments

In the said rules, -

- (1) for sub-rule (2) of rule 18, substitute the following sub-rule :-
 - "(2): Every certificate of registration granted under sub-section (2) of section 7 shall contain the following particulars, namely:—
 - (a) the name and address of the establishment;
 - (b) the type of business, trade, industry, manufacture or occupation which is carried on in the establishment;
 - (c) the maximum number of workmen employed directly on any day in the establishment;
 - (d) number of workmen employed as permanent or regular workmen;
 - (e) number of workmen employed as temporary or casual workmen;
 - (f) the maximum number of workmen employed or likely to be employed as Contract Labour in the establishment;

- (g) Whether the workmen employed or intended to be employed by the contractor periods the same or similar kind of work as the workmen employed directly by the principal employer. If yes, details of such activities;
- (h) the names and addresses of the Trade Unions operating in the establishment;
- (i) Settlement or Award or Judgment or minimum wages, if any, applicable in the establishment;
- (j) such other particulars as may be relevant to the employment of Contract Labour in the establishment."
- (2) after sub-rule (1) of rule 21, insert the following sub-rule:-
 - "(1A) Every application in Form No. IV shall contain a declaration on matters of nomenclature of contract labour, details of likely wage rates to be paid to such contract labour, other conditions of service like leave, holidays, hours of work etc. of the contract labour."
- (3) after sub-rule (1) of rule 29, insert the following sub-rule:-
 - "(1A) Every contractor shall also furnish in Form No. VII mentioned in sub rule (2) (i) a declaration in respect of the contract labour on the rates of wages paid, hours of work maintained, holidays and leave allowed, special benefits provided, if any, and (ii) a declaration as to the contributions made towards any fund under the Employees' State Insurance Act, 1948 and the Employees' Provident Fund and Miscellaneous Provisions Act, 1952."
- (4) for Form No. I, substitute the following Form :-
