In exercise of the power conferred by clause (c) of section 2 of the Beedi and Cigar Workers (Conditions of Employment) Act, 1966 (Act 32 of 1966) (hereinafter referred to as the said Act), the Governor is pleased hereby to authorise the officers shown in Column (1) of the schedule below as the competent authorities for the purposes of section 4 of the said Act and to define the limits shown in the corresponding entries in column (2) of the said schedule within which such competent authorities shall exercise the powers conferred on them under section 4 of the said Act.
