#### NOTIFICATION

No. 1046-EIL/1A-02/2010, dated 01.10.2010.—In exercise of the power conferred by section 16 of the West Bengal Motor Transport Workers' Welfare Cess Act, 2010 (West Ben. Act V of 2010), the Governor is pleased hereby to make, after previous publication as required under sub-section (1) of section 16 of the said Act, the following rules, namely:—

#### Rules

- **1. Short title and commencement.**—(1) These rules may be called the West Bengal Motor Transport Workers' Welfare Cess Rules, 2010.
- (2) They shall come into force on and from the day of the Publication in the *Official gazette*.
- **2. Definitions.**—(1) In these rules, unless there is anything repugnant in the subject or context,—
  - (a) "Act" means the West Bengal Motor Transport Workers' Welfare Cess Act, 2010 (West Ben. Act V of 2010);
  - (b) "Cess Authority" means the authority appointed under sub section (1) of section 3 of the Act;
  - (c) "Year" means a Financial Year commencing on the first day of April.
- (2) All expressions used in these rules which are not defined, but defined in the Act, shall have the same meaning assigned to them in the Act.

### 3. Furnishing of return.

- (1) Every Cess Authority shall submit return regarding collection of cess in Form-I to—
  - (a) the Board;
  - (b) the District Magistrate of the area or the Director Public Vehicles Department in case of Kolkata; and
  - (c) the concerned Deputy Labour Commissioner.
- (2) The returns under rule (1) shall be sent to the authorities specified in the said sub-rule so as to reach them within tenth day of every month. The return may also be sent to the Board through E-mail or through on-line.

### 4. Payment of cess.

- (1) Cess payable under the Act shall be collected by the 'Cess Authority' either in cash or by demand draft drawn in favour of the Board.
- (2) The Cess Authority shall not collect any cess without giving a receipt of such collection. The fact of such payment of cess shall also be endorsed in the 'cess token'. A common receipt of cess collection along with collection of tax under the West Bengal Motor Vehicles Tax Act, 1979 (West Ben. Act IX of 1979) may be issued. Similarly a common token may be given.
- (3) Amount collected by the Cess Authority in cash or by demand draft shall be deposited to the State Bank of India in favour of the Board immediately. If for some unforeseen circumstances the amount could not be deposited on the same day, the same shall be deposited in the next working day.
- (4) Every owner of a motor vehicle liable to pay cess under the Act shall pay cess alongwith tax payable under the West Bengal Motor Vehicles Tax Act, 1979 within the time specified under section 11 of the West Bengal Motor Vehicles Tax Act, 1979.
- (5) The Cess Authority shall collect cess with interest or penalty wherever such interest or penalty is payable.
- (6) Every owner of a motor vehicle liable to pay cess under the Act shall submit
  - (a) details of cess paid during the year in respect of such vehicle through a return in Form-II in the month of April every year; and
  - (b) details of owner of the vehicle in respect of which cess is payable in Form-II A within ninety days of coming into force of these rules. Changes, if any, in the information submitted shall also be communicated in the same form, i.e Form-IIA (Revised) within thirty days of such change to the Board and the concerned Deputy Labour Commissioner.
- (7) The cess token shall be displayed conspicuously in all motor vehicles for which the cess under the Act is payable.
- 5. Claim of refund.—(1) If any refund is allowed under section 13 of the West Bengal Motor Vehicles Tax Act 1979, corresponding refund of cess collected under the Act may be allowed.
- (2) If any refund is allowed under sub rule (1) or by an order of the Appellate Authority under the Act, the 'Cess Authority' shall issue a certificate in Form-Ill, duly countersigned by the District Magistrate or the Additional District Magistrate in case of districts other than Kolkata or the Director Public Vehicles Department or Deputy Director Public Vehicles Department in case of Kolkata, to the concerned owner of the motor vehicle with a copy to the Board. Such certificate shall specify the amount of cess collected and the amount is required to be refunded under the Act along with the reasons of such refund.

- (3) The Board or any other authorized officer of the State Government shall, on production of such certificate in Form-Ill refund excess amount collected as cess to the concerned owner of the motor vehicle by cheque.
- **6. Imposition of interest or penalty and its recovery.**—(1) The Cess Authorities shall recover cess and impose interest or penalty payable under the Act.
- (2) For recovery of dues payable under the Act, provisions of section 11 of the Act shall be applicable.
  - (3) Every order made under this rule shall be forwarded to
    - (a) the Board;
    - (b) the concerned Deputy Labour Commissioner;
    - (c) District Magistrate in the district other than Kolkata or the Director PVD in case of Kolkata.
  - (4) The Board shall record every order made under this rule in a register.
- 7. Appeal.—(1) An appeal under section 15 of the Act shall be preferred to the District Magistrate in the case of a district other than Kolkata and to the Director PVD in case of Kolkata accompanying non-refundable fees of one hundred rupees in cash.
- (2 An appeal under this rule may be made in plain paper setting forth the order against which the appeal is preferred and the reasons of such appeal.
- (3) No appeal under this rule shall be accepted if the order appealed against has not been complied with and a certificate of such compliance from the concerned officer or the authority has not been enclosed.
- (4) The Appellate Authority after allowing the parties an opportunity of being heard and after such enquiry, if any, as it may deem necessary may confirm, modify or set aside the order from which the appeal is preferred and replace it by a new order.
- (5) An appeal shall be preferred within thirty days from the date on which the order under appeal was received.
- (6) Every order made under sub-rule (4) shall be forwarded to the officer or the authority whose order was appealed against. Copy of every such order shall also be sent to the Board and the concerned Deputy Labour Commissioner.
- (7) On receipt of an order under sub-rule (6) an officer or the authority under the Act, whose order was challenged, shall take due action as per such order within seven days with an intimation to the Board.

### 8. Registers.

The Board shall maintain—

- (a) a register of motor vehicle for which cess is payable in Form-IV;
- (b) a register of cess received from motor vehicles in Form-V;
- (c) a register of deposits to the bank in Form-VI; and
- (d) a register of orders in connection with recovery of interest or penalty in Form-VII.
