**CIRCULAR**

The Government of West Bengal in the Labour Department has fixed minimum rates of wages in the employment of **BRICK MANUFACTURING** in the state of West Bengal as per notification number 120-MW/2W-08/14 Dated 19.11.2015. These rate will be effective for the period from **1st January, 2020 to 30th June, 2020**.

a. The classification of employees in the above employment is as follows :-

**Unskilled Workers:** Earth Cutter/Matikata, Paniwala, Boyal Hakka, Mukkata, Loader/ Reza/Banki, Ticket Batta, Rubbishman, Mazdoor, Coalman, Muddhawa, Mutphulla/Jabwala, Tubwaya, Chowkidar/Night Guard/ Darwan/Peon, Vanwala..

**Semi-skilled Workers:** Loading Mistry, Belder, Sajnder, Sorting Mistry, Sorter, Pathora.



**Skilled Workers:** Fireman, Lorry Driver, Munshi.

- b. There will be only one rate of minimum wage for the whole of West Bengal.
- c. To arrive at daily rates, monthly rates shall have to be divided by 26 and to be rounded off to the nearest rupee and to arrive at weekly rates, daily rates shall have to be multiplied by 6.
- d. A normal working day shall consist of eight and half hours of work including interval for half-an-hour for rest.
- e. One day in any period of seven days as may suit the local convenience shall be the day of weekly rest.
- f. The minimum rates of wages include the wages for weekly day of rest. Payment for work done on the day of weekly rest and for work done beyond the normal working hours shall be double the ordinary rate of wages.
- g. Where the existing rates of wages of any employee based on contract or agreement or otherwise are higher than the rates notified herein, the higher rates shall be protected and treated as minimum rates of wages applicable for the purpose of this notification to such employees.
- h. The minimum rates of wages are applicable to employees employed by contractors also.
- i. The minimum rates of wages for disabled persons shall be same as payable to the workers of appropriate category.
- j. The men and women employees shall get the same rates of wages for the same work or work of similar nature.
- k. The minimum rates of wages and Variable Dearness Allowance, if any, both together shall constitute the minimum rates of wages to be enforceable under the Minimum Wages Act, 1948(11 of 1948).
- l. The daily earnings of a piece rated employee shall not be less than the rate for a daily rated employee.
