CIRCULAR

The minimum rates of wages for those in the employment of **SALT MANUFACTURING INDUSTRY** in the state of West Bengal covered as per notification number 456-MW/2W-60/2006 dated 22.09.2011 are being hereby fixed as under. These rates will be effective for the period from **1st January**, **2022 to 30th June**, **2022**.

a. Now, with reference to the said notification, the following shall be the minimum rates of wages in the said employment for the period from 1st January, 2022 to 30th June, 2022.

Categories of Employees	Monthly Minimum Rates of Wages(Rs.)
Unskilled	7,044.00 (Daily - 271.00)
Semi-Skilled	7,750.00 (Daily - 298.00)
Skilled	8,527.00 (Daily - 328.00)
Highly Skilled	9,380.00 (Daily - 361.00)

b. The classification of employees in the above employment is as follows:-

Unskilled Workers: Persons engaged in earth cutting, bundh and boundary making, field preparation, bed preparation, earth drain making or repairing, salt lifting from the bed and stocking, filling in bags, loading and unloading including carrying, packing and weighing and office peons, general mazdoors, sweepers, tea boys.

Semi-skilled Workers: Machineman helper, electrician helper, salt washing mazdoor, measurement man for water evaporation, watchman, nightguard, Manson helper, carpenter helper, and cook.

Skilled Workers: Machineman both water lifting and salt crushing, electrician, carpenter, manson, weighman(if not clerk), leader in field and water lifting, Time-office clerk, office clerk, tally clerk and godown keeper/clerk.

Highly Skilled Workers: Field supervisor, factory supervisor (not the leader) and supervisor-cum-field manager.

- c. There will only be one rate of minimum wage for the whole of West Bengal.
- d. To arrive at daily rates, monthly rates shall have to be divided by 26 (to be rounded off to the nearest rupee) and to arrive at weekly rates, daily rates shall have to be multiplied by 6.
- e. A normal working day shall consist of eight and half hours of work including interval for half-anhour for rest.
- f. One day in any period of seven days as may suit the local convenience shall be the day of weekly

rest. The minimum rates of wages include the wages for weekly day of rest. For payment for work done on the day of weekly rest and for work done beyond the normal working hours shall be double the ordinary rate of wages.

- g. Where the existing rates of wages of any employee based on contract or agreement or otherwise are higher than the rates notified herein, the higher rates shall be protected and treated as minimum rates of wages applicable for the purpose of this notification to all such employees.
- h. These minimum rates of wages are applicable to employees employed by contractors also.
- i. The minimum rates of wages for disabled persons shall be same as payable to the workers of appropriate category.
- j. The men and women employees shall get the same rates of wages for the same work or work of similar nature.
- k. The minimum rates of wages and Variable Dearness Allowance, if any, both together shall constitute the minimum rates of wages to be be enforceable under the Minimum Wages Act, 1948(11 of 1948).
