CIRCULAR

The Government of West Bengal in the Labour Department has fixed minimum rates of wages in the employment of **Glass Industry** in the State of West Bengal as per notification number Labr/627/LC- MW Dated 20.12.2019, as published in the Kolkata Gazette Extraordinary dt. 24.12.2019.

- a) Now, with reference to the said notification, the following shall be the minimum rates of wages in the said employment for the period from **1st July, 2021 to 31st December, 2021.**

Unskilled	8904.00 (daily 342.00)	7929.00 (daily 305.00)
Semi-Skilled	9795.00 (daily 377.00)	8720.00 (daily 335.00)
Skilled	10775.00 (daily 414.00)	9593.00 (daily 369.00)
Highly Skilled	11851.00 (daily 456.00)	10554.00 (daily 406.00)

- (b) **Implementing areas:**

Zone 'A'=(i) Areas under Municipal Corporations, Municipalities, notified Areas/ Authorities, Development Authorities, Thermal Power Plants Areas including Township Areas;
Zone 'B'=Rest of the West Bengal.

- (c) The classification of employees in the above employment is as follows:-

UNSKILLED: Annealing chamber coolies; Furnace Coolies, Carrier (Jaliwala) coolies, General coolies, Poker, Mason (Helper), Batch coolies (Batch room), Sweeper, Canteen Boys, Chimney Grinder, Lorry Mazdoors.


SEMI-SKILLED: Bubbler / Bubbler Helper, Lineman, Airman, Fireman Helper, Meltors, Blacksmiths, Grinder and Polisher, Cook, Sorter, Rulswala (Non maker)

SKILLED: Lorry Driver, Fireman, Flower (Ord), Helper to Blower, Machineman (Cutter), Machineman (Helper), Cutting off Fine Polishing, Machine Operator, Fitter Mechanic, Electrician, Turner, Latheman, Welder

HIGHLY SKILLED: Blower, Foreman, Shift-in-Charge.

- (a) For Zone A, CPI (IW), Kolkata Centre, Base Year 2001 = 100.
For Zone B, CPI (IW), Kolkata Centre, Base Year 1986-87 = 100.
- (b) To arrive at daily rates, monthly rates shall have to be divided by 26 and to be rounded off to the nearest rupee and to arrive at weekly rates, daily rates shall have to be multiplied by 6.
- (c) A normal working day shall consist of eight and half hours of work including interval for half-an-hour for rest.
- (d) One day in any period of seven days as may suit the local convenience shall be the day of weekly rest.
- (e) The minimum rates of wages include the wages for weekly day of rest. Payment for work done on the day of weekly rest and for work done beyond the normal working hours shall be double the ordinary rate of wages.
- (f) Where the existing rates of wages of any employee based on contract or agreement or otherwise are higher than the rates notified herein, the higher rates shall be protected and treated as minimum rates of wages applicable for the purpose of this notification to such employees.
- (g) The minimum rates of wages are applicable to employees employed by contractor also.
- (h) The minimum rates of wages for disabled persons shall be same as payable to the workers of appropriate category.
- (i) The men and women employees shall get the same rates of wages for same work or work of similar nature.
- (j) The minimum rates of wages and Variable Dearness Allowance, if any, both together shall constitute the minimum rates of wages to be enforceable under the Minimum Wages Act, 1948 (11 of 1948).


